To be eligible for our 2018 early-bird discount and receive 10% off all entries, a \$500 non-refundable deposit along with this form is required for studios with entry fees totaling \$2,500 or more. Studio's with entry fees under \$2,500 are still encouraged to submit this form with a \$300 non-refundable deposit. Please note that any studio that received a 2017 studio award credit exceeding \$500 is not eligible to receive the early-bird discount, but is still encouraged to submit an early commitment deposit. All discounts will be calculated after all registrations are submitted from the total studio invoice. This includes the early-bird discount and any studio credits awarded from the previous season. Studio credits hold no cash value and can only be used towards entry fees.

Please choose from the following:

- ELIGIBLE FOR EARLY-BIRD DISCOUNT:** Entry fees exceed \$2,500 and do not have a 2017 studio award credit over \$500 (submit \$500 non-refundable deposit).

- EARLY STUDIO COMMITMENT:** Entry fees exceed \$2,500, but we have a 2017 studio award credit over \$500. I understand that I am not eligible for the early-bird discount (submit \$500 non-refundable deposit).

- EARLY STUDIO COMMITMENT:** Entry fees are under \$2,500 and I understand we are not eligible to receive the early-bird discount (submit \$300 non-refundable deposit).
